### **CCIP Eligibility Requirements**

- -Bachelor's degree or higher plus three years of experience in investigations, IT, fraud, law enforcement, forensics, criminal justice, law, and loss prevention. OR
- -Associates degree plus four years of experience as stated above. OR
- -High school diploma or equivalency plus four years of experience as stated above.

Also, a person convicted of a felony, any crime of moral turpitude or misdemeanor relating to honesty, theft, embezzlement, fraud, or the like shall be ineligible to become a CCIP®. Applicant must provide a copy of a certified transcript of education ONLY if using a college degree rather than experience to qualify. Applicants must successfully pass the prescribed background check, which may include a criminal background check and examination process. Falsification or omission of information on the application form will be reason enough to disqualify an applicant from becoming or remaining a Certified Cyber Intelligence Professional.





#### **Exam Development**

In developing the CCIP examination specifications, M.I. drew upon the knowledge and expertise and skill sets of intelligence and investigative professionals at the director level and above. The professionals came from different industries and functional areas with the intelligence and investigation sectors to determine the content of the examinations.

### Number of Questions and Length of Time Allowed to Complete the Exam

The examination consist of 175 questions and you are allotted three hours and thirty minutes to complete it.

### Making Your Appointment with ProctorU

Once you purchase your exam license. You will schedule your proctor session from within the course environment. The proctor fee is included in the exam cost.

### **Canceling or Rescheduling Your Appointment**

Should you need to reschedule your exam you must do so at least 48 hours in advance or you will be accessed a rescheduling fee of \$99.

### No show for the exam

If you fail to show for your exam your exam fee will be forfeited. You will need to purchase a new exam license to sit for the exam.

### Dismissal from the Exam

A candidate may be dismissed from the exam at the discretion of the proctor, for improper or disruptive behavior. Ground for dismissal include:

- -Cheating
- -Receiving Help
- -Impersonating another candidate
- -Falsifying Identification

### **Computerized Testing**

Q. How much experience is needed to test?

A. No experience necessary to operate the testing platform. Candidates receive an online tutorial on the testing process. The is also a live proctor during the test to help out as well.

Q. Can I review my answers during the test?

A. A candidate may flag questions to be reviewed after all questions have been answered. If time remains you may return to questions marked for review and you may change your answer. All marked and unmarked questions are graded when the test ends, even if the candidate has not marked a response to a question.

### **Special Accommodations**

If you have a disability that would prevent you from taking the CCIP exam under standard conditions, you may request special accommodations. Please contact the M.I. Certification team at certifications@mcafeeinstitute.com

### I.D. Requirements

For your exam, you will need to bring two forms of ID: Your ID MUST be of one of the following: Drivers License, Passport, State ID, Military ID, Offical State, Government or National ID, Employee ID, or Student ID.

No other forms of I.D. will be accepted.

### **Computer Requirements**

You need to have a computer with a camera and microphone. You need to have the most up to date web browser to take the exam. We recommend firefox or chrome.





### Weighting Process for Exam Task

Successful completion of the exam by obtaining a 70% or better.

### Value of Each Exam Question

To maintain consistency in test scoring, a statistical process called scaling is used. Scaling converts all scores to a scale from 0-100. Passing score is a 70. If you earn between 0-69 you've failed. If your score is 70-100 you have passed.

### Weighing Process for Exam Task

A group of practitioners and subject matter experts (SMEs) met and determined the weight of each task area compared to all other task areas in exams. The final weight assigned to each task determines its number of questions on the exam from each task area.

### Value of Each Exam Question

All exam questions are worth the same weight regardless of their length. Candidates receive one point for a correct answer and zero points for an incorrect answer. Sample questions are not used to determine scores. Candidates are advised to choose an answer for every exam questions, even if they are unsure of the correct answer.

### What if I fail?

If you enrolled via one of our board certification programs your exam and first proctor session are included in the cost of the tuition.

If you fail your exam, you will need to purchase a new exam license. You will also have to purchase a new proctor session.

If you purchased the exam license by itself and you fail you would need to purchase an additional exam license.

### **Retention of Score Reports**

Candidates are responsible for retention of their original score reports.

### **Types of Questions In the Exams**

All of the questions used on the Exam are of the true/false or multiple-choice type, with multiple options per question (labeled A, B, C and D for example), only one of which is correct. There are, however, several variations of this type of question appearing on the exam. The most commonly used formats are:

Closed-Stem Item: In this type of question, the examinee is asked a question and given four possible answers from which to choose. Example:

Which of the following is a type of social network?

- (A) Google
- (B) Facebook
- (C) Bing
- (D) Yahoo Answer: B

Sentence Completion Item: This question is characterized by an incomplete sentence, followed by options that represent conclusions to that sentence.

Example:

The \_\_\_\_\_ provides guidelines for managing a forensic lab

- (A) McAfee Institute
- $(B)\ The\ Federal\ Bureau\ of\ Investigation\ (FBI)$
- (C) American Society of Crime Laboratory Directors (ASCLD)
- (D) National Lab Society Answer: C

EXCEPT Format: In this type of question, an examinee is required to recognize that there are three correct responses within the question. The respondent does this by identifying the incorrect option. A variation on this type of question is to use the word NOT instead of EXCEPT in the stem, in the form of, "Which one of the following is NOT..."

Example The steps in the evidence include all of the following EXCEPT

- (A) Collection and identification
- (B) Storage and Retrieval for Court
- (C) Presented in court
- (D) Selling at the auction Answer: D

True/False: This question is answered by picking out if the question is true or false.

Example:

Social Media can be used to obtain evidence to support criminal activity.

- (A) True
- (B) False Answer: A





### Applying for the Designation

When are ready to take the exam. You will complete the exam application from within the exam environment. You will attest to your education and professional work experience. You will then send in supporting documentation (we do not allow self-verification of work experience) and your regionally accredited Bachelors' Degree or International equivalent and mail them to McAfee Institute, at the address documented on the application form.

### **Maintaining Your Certification**

To maintain the certification, CCIP's must earn 25 Continuing Professional Education Credits (CPE) during their two-year certification process. In addition, there is a \$125 renewal fee every two years.

### What Type of CPE are required:

The following general subjects are acceptable as long as they meet other CPE program criteria:

- Law Enforcement, Investigations, Fraud
- Loss Prevention, Auditing, Inventory Control
- Intelligence, Military, DOD
- Management and communication (oral and written)
- Computer Science, IT Security, Infrastructure
- Mathematics, statistics, and quantitative applications in business
- Business Law, Legal, Courtroom

### How are CPE calculated?

CPE credits are calculated as per on the hour basis. Every 1 hour of training equates to .50 credits.

### When are CPE Due?

CPE credits are due before your certification expires. Simply follow this link to pay your renewal fee and report your CPE credits today!

### **Educational Activites Include:**

- 1. Professional education and development programs, such as seminars and conferences, provided by national, state and local auditing, and accounting organizations.
- 2. Technical sessions at meetings of national, state, and local auditing accounting organizations, and chapters. Formal in-house training programs.
- 3. Programs of other sponsors (industrial, professional societies, etc.).
- 4. College or university credit and non-credit courses passed, except for those courses a student must take to meet the examination requirement of a bachelor's degree or its equivalent.
- 5. Other certification examinations passed.
- 6. Formal correspondence and self-study programs are relevant and include evidence of completion.
- 7. Oral Presentations

### **CCIP Reinstatement (Grace Period)**

You are permitted a one-year grace period that takes place if you allow your designation to lapse. During this timeframe, you no longer hold the certification and cannot use the designation (this includes but is not limited to business cards and LinkedIn profiles).

Your name will not appear in the verification section of the ISM website. Keep in mind that dates will appear on the certificate as if your recertification had been completed prior to the expiration of your previous certificate. At any time during your grace period, a recertification application can be submitted containing the required 25 CPE's for the previous period. Applications must be postmarked on or before the one year anniversary of your expiration date. Once the grace period has lapsed, the only way to reinstate your designation is to purchase, retake and pass the exam and submit a new original exam application.
